This grant enables MiSEN to sustain its operations and assist eligible educational institutions in joining the State Education Network (SEN). Through SEN, participants gain access to regional and statewide collaboration, high-speed transport and internet services, and robust cybersecurity protections, including DDoS mitigation.
